*The Engineers Registration Board Regulations, 1999, provide as follows:*

- (1) *A person whose application for registration as a Professional Engineer has been approved shall within two months of the date of notification of such approval, pay to the Board a registration fee of an amount as the Board may prescribe.*
- (2) *A person who fails to pay the registration fee within the period stipulated shall be treated as if he has withdrawn the application and no subsequent application from him shall be considered before the expiry of six months from the date on which the previous application was approved unless that person pays the fee and a fine not exceeding fifty percent of the current registration fee. All Engineers are therefore urged to pay their fees within the stipulated period.*

**NOTE:**

- (1) It is **ILLEGAL** to practice engineering if not registered with the Board.
- (2) It is **ILLEGAL** to employ **unregistered** engineers.
- (3) It is **ILLEGAL** to offer engineering consultancy services if the Engineer or the Firm is not registered as Consulting Engineer or Engineering Consulting Firm respectively.
