THE ENGINEERS REGISTRATION (AMENDMENT) BY-LAWS, 2018

Citation

GN. No. 25 of 2010

1. These By-laws may be cited as the Engineers Registration (Amendment) By-laws, 2018 and shall be read as one with the Engineers registration By-laws, 2010 hereinafter referred to as the "principal By-laws".

Amendment of First Schedule

2. The principal By-laws are amended in the First Schedule by deleting it and substituting for it the following new Schedule-
